





Sir,

I have the honour to state that on 03/05/2023 night 8:30 pm and 04/05/2023 around 11:30 am some unknown miscreants belonging to Meitei Youths Organisation suspected to be members of Arambai Tenggol group, Meitei Leepul and Kangleipak Kanba Lup (KKL), World Meitei Council (WMC) and Schedule Tribe Demand Committee (STDC) about 900-1000 members carrying sophisticated weapon like AK, Rifles, SLR and 303 Rifles with vehicles forcefully entered in my home located at Paite Veng Imphal West P.O Sangaiprou P.S Lamphel and Lamphel Sub Division Imphal West District, Manipur. They looted all the valuable household and burnt down to ashes leaving us homeless. The approximate value of movable and non-movable lost and destroyed properties is estimated to be about Rs 1.32 crores

It is therefore, requested to kindly registered a regular case and take necessary legal action according to law.


