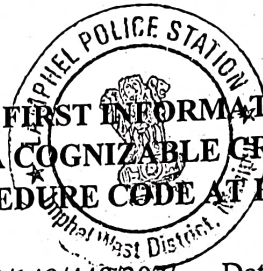

Subject: FIR against Destroyed, looting and burning down my house.


Sir,

I have the honour to report that on 4th May, 2023 (Evening) some unknown mobs numbering about 1000 persons suspected to be Arambai Tenggol, Meitei Leepun, Kangleipak Kanba Lup forcefully attacked my house with intend to murder I and my families. At a moment they were destroyed, looted all my belongings household properties and some valuable items including important documents and later burnt down my house at Khongsai Veng, Laipham Khunou, House No. 28 (Twenty eight) Imphal East District, Manipur. The total lost properties is estimated approximately Rs. 3 Cores.

I, therefore, humbly request you to kindly look into the matter and take necessary legal action.


