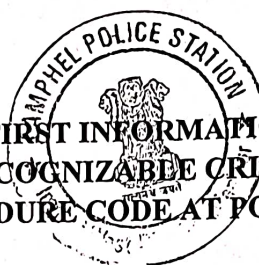

Arambi Tengol my rent colony Khongsai Veng
located at Laiphom Biphai Imphal east, have been
receiving end of most inhumane activities by the
radical mob

The incident was so sudden we had no time
to pack anything including important documents and
valuable items in the process they have looted all valuable
items including jewellery, house hold items, clothes and
later destroyed and burnt down the properties. The details
of property affected is enclosed.

In this regard I would like to request you to
kindly take up further necessary legal action against
those miscreants involving in property theft destruction
