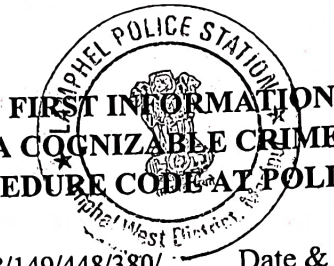

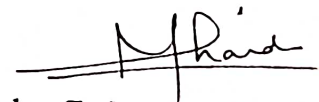

distraction looting of property.

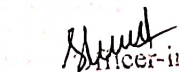
With due respect and humble request that
