With due respect, I would like to inform you that on 25th May 2023 at around 10:00 pm some valley based organisations suspected to be volunteers of Arambam Tenggol, Kangleipak Kanba Lup (KKL), Meitei Leepun, broke into my residential quarter at National Games Village, Zone-I, B-248 and looted all my household properties worth around 40 (forty lakhs) only which includes very important personal documents and a sum of Rs. 5,30,000/- (five lakhs thirty thousand) only in cash which was kept inside the Godrej(almirah)


I therefore request you to take up necessary legal action regarding the incident.


