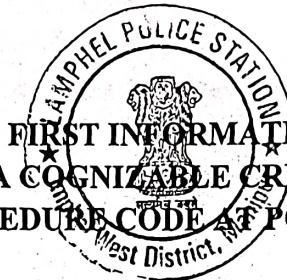





I have the honour to state that, on 28th May, 2023 at about 3 pm every large numbers of unruly mob suspected to be Arambai Tenggol, Kangleipak Kanba Lup, Salaicha Pibarel Pungsi Marup and Meira Paibeas carrying a deadly weapons and sophisticated arms attacked and dismantled my quarter Type-III, A-4 located at Lamphel by pelting stone and damaged all my household. 
