

Sir,

I, the undersigned have the honour to state that, on 3rd May, 2023 at around 4:30 pm, large number of innumerable unidentified groups of people belonging to Kuki community with deadly weapons and sophisticated arms including Kuki militants' groups stormed and attacked to all Meitei inhabited area of Moreh town. The said groups looted all the properties from my house and shop located at Moreh Khunou Leikai W/No. 9 and they had also burnt down my house and shop. After the said unfortunate incident, my family fled from our village to save our life. The value of the properties lost/damaged is estimated a total amount of Rs. 45,00,000/- (forty-five lakhs).

I, could not report the incident to my concerned Police Station as well as in time due to the prevailing law and order situation in the state.

I, therefore request your good office to kindly take up necessary legal action against the accused persons and the persons involved in the said inhuman acts and heinous crime committed by them as per law of the land as early as possible.

I shall be grateful for your kind co-operation and necessary action.
