Subject: Complaint report.

Sir,

I am to state that, on 30th May 2023 at about 8: 00 pm, a large number of miscreants/mob belonging to Meitei community went to my locality Khongsai Veng, Laipham Khunou under Lamphel Police Station (Imphal West and falling under revenue of Imphal East) and forcefully intruded into my house (NO. 181). They looted all my properties (Furnitures, electronic items, clothing, grain, etc) worth 16,70,000/- (Sixteen Lakhs Seventy Thousand) approximately including 1.7 lac in cash.

It is, therefore, kindly requested to take necessary legal action to arrest the culprit involved in the incident at the earliest in the interest of justice. I hereby lodged my complain at Kangpokpi Police Station as I had fled from my residence to safe myself and my families from the rioters.


