
With due respect, I would like to inform you that on 21st May 2023 at around 10:00 pm some valley-based organisations suspected to be volunteers of Arambai Tenggol, Kangleipak Kanba Lup (KKL), Meitei Leepun, broke into my residential quarter at National Games Village C-59/ Zone-2 and looted all my household properties worth approximately around 45 (forty five lakhs) only which includes very important documents and a sum of Rs. 7,50,000/- (seven lakhs fifty thousand) only in cash which was kept inside the Godrej (almirah)

I therefore request you to take up necessary legal action regarding the incident.
