Sir,

For your kind information, on the enter-vening night of
3rd May '2023' at around 10:30 PM, some miscreant suspected
to be members of so called Meitei youth organisations such as
Meitei Leepun, Kanglipak Kanba Lup (KKL), Arambai Penggol
and Women Wings and Schedule Tribe Demand Committee (STDC)
members were seen looting and vandalising the Kuki's house-
hold properties at Langol Housing Complex, under Lamphol police
station, Imphal East, Manipur.

Therefore, I am Compel to leave/vacate my residential quarter
(Type - III, # - 19, L#C) as a precautionary measures for the safety
and well-being of my whole family members without any house-
hold items which is said to be looted and vandalised thereafter.

The approximate value of properties looted and vandalised
is estimated to be around Rs. 10,57,000/- (Ten lakhs fifty seven
thousand).
