With due respect, I would like to inform you that on 24th May 2023 at around 9:00 pm some valley-based organisations suspected to be volunteers of Arambai Tenggol, Kangleipak Kanba Lup (KKL), Meitei Leepun, broke into my residential quarter at National Games Village, B-378/ Zone-1 and looted all my household properties worth around 43 (forty-threelakhs) only, which includes very important documents and my 2 (two) wheeler (Jupiter TVS Classic) was also burnt down by the miscreants.

I therefore request you to take up necessary legal action regarding the incident.
