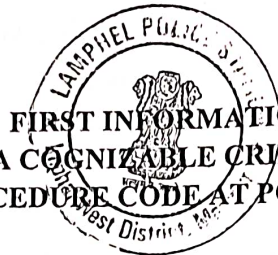



With due respect, I the undersigned would like to inform you that, on 4th May. 2023, at around 11:00 p.m, Meitei miscreants suspected to be members of ARAMBAI TENGGOL, MEETEI LEEPUN and KANGLEIPAK KANBA LUP and others attacked my residence at Emmanuel Colony National Game village, Imphal West and they burn down my house into ashes thereby losing all my properties estimated to be around 5,00,000/- (Fifty lakhs).

I could not report the incident to my concern Police Station as well as in time due to the prevailing situation in the state.

It is therefore requested you to kindly register a regular case and take necessary legal action according to law.
