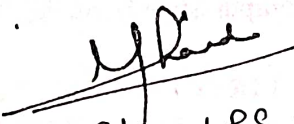

lines for your kind consideration and necessary action.

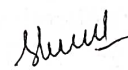
That, Sir on 7th May, 2023 unknown miscreants
