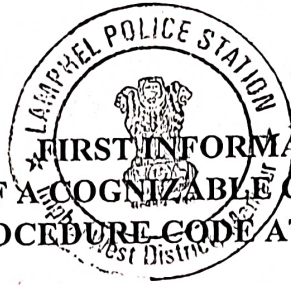


It is therefore request to kindly register a regular case in your good office against the culprits according to the law.
