

Subject: FIR in connection with burning of lease house

Dear Sir,

I would like to state that I was staying in Ningthemkol Kwakeithel, Opposite PTC (Pastorial Training Centre) Imphal-West at the plot building of T. Hangzo S/o. Late Zamkothang on a lease accommodation provided by my employer, Reserve Bank of India. During my absence on May 04 2023, at about 2:00 pm the leased accommodation was burnt down and my properties/belongings inside the house were completely burnt/looted by unknown miscreants during the Ethnic unrest/clashes in Imphal. The estimated loss on account of the damages stated above is around **Rs. 32,83,117/- (Rupees Thirty Two Lakh Eighty-Three Thousand One Hundred and Seventeen only)**. The other losses priceless in nature, which are listed in item No. 3 below were not assessed in terms of value.

I am submitting this report with humble request for registering an FIR for taking necessary action against those perpetrators and recovery of the lost assets. I could not report to the police timely as I was collecting the material list/compiling details of the lost /burnt properties. Enclosed herewith the following details for your information and necessary action.


