. Sir,

I have the honour to submit herewith a detailed status report for favour of your kind and compassionate consideration in the above cited subject. In that the complainant Lalruotvel of F-46, type-III, Langol Housing Complex, Imphal-West District, Manipur serving as Draftman (Grade-III), Minor Irrigation Department, Government of Manipur (MGEL No.000784) (B), now residing at D-II, Nanakpura, Motibagh, New Delhi lodged a complaint filed online through HRCNet on 09/06/2023 stating that, on 3rd May 2023, a communal violence has erupted in the state of Manipur and she along with her son Mr. Omega Chongrobul have to run for their life to have a safe shelter in CRPF campus in Lamphelpat, Imphal, Manipur. They had no chance/opportunities to grasp their belongings due to the prevailing situation such as arson, looting, mass murders with utter disturbance of law and order prevailing in the state of Manipur. After staying under the protection of the Central Government Armed Forces campus for 6(Six) days, they had a chance to escape from the ethnic violence in Imphal, Manipur on 09/05/2023 and temporarily residing with her sister at D-II, Nanakpura, Motibagh, New Delhi. She has left her moveable's properties as earned towards her life savings during her past 28 years' service in the Government of Manipur with the average cost of her entire moveable property lying in her quarter will amount to approximately Rs.95 Lakhs (In current value, 2023) is currently under threat and being looted by miscreants of the residents of Imphal, Manipur. She learnt from a reliable phone call (withheld due to security reasons) that all of her movable properties have been continuously lootings by thieves/miscreants with vehicle No.MN01F-4161 on 2<sup>nd</sup> of June, 2023 to 4<sup>th</sup> June, 2023. These lootings happened during the alleged imposition of Article 355 of the constitution of India where Law & Order is solely with the State/Union CAPF (Central Armed Police Force) and under the strict supervision of the State Police forces. Thus, seeking protection of life and properties and request to register an FIR against the Home Department of Government of Manipur under section 446,448,441,420 and other relevant section of the Indian Penal Code and initiate immediate investigation & necessary actions. And

as a citizen of India, she is liable to be compensated immediately and give a direction to the Government of Manipur within a time limit as prescribed by the H'ble National Human Rights Commission of India.

That, on received of the complaint filed by the complainant, the H'ble Chairperson, Manipur Human Rights Commission passed an oral order issuing notice upon the commissioner (Home), Government of Manipur to submit a status report with a direction to send a copy of the complaint petition to DGP, Manipur for doing the needful in accordance to law.

Accordingly, under endorsement No. 6/20/SP-IW/2023 (MHRC)(Pt-19), the Superintendent of Police, Imphal-West District, Manipur directed to the Officer-In-Charge, Lamphel PS to enquire into the matter and furnish a detailed status report enclosing the relevant documents. As directed, conducted an enquiry as follows:

Visited at the spot i.e F-46, type-III, Langol Housing Complex, Imphal-West District, Manipur located at Langol and on observation, it is found that the Government quarter is located in between quarter No. 47 and 45 occupied by Mr. Samual Mungkung of Sorbung, Kamjong District, Manipur and Mrs Esther Hmar respectively. The quarter of the complainant's main gate was found half open as well as the main door and the back doors of the quarter are all found open. Inspected inside the rooms of the quarter in presence of 2(Two) witnesses namely Rammayon R. Shimray of Hundung Goda, Kamjong District, Manipur & Haobijam Samu Singh of Sagang, Churachandpur District, Manipur who are the occupants of quarter No. 48 & 44 and civilian witnesses. There are 4 (Four) rooms excluding one kitchen and one bathroom in the quarter, no house hold articles mentioned in the complaint report was found and some old wearing garments and unused cloths & cooking utensils are found scattered inside the rooms. Photographs of the ransacked and scattered spot are also taken for reference. Examined some individuals residing in and around the quarter of the complainant including the Meiteis & Tribe communities. On examination they all stated that they can't say when the complainant have left her quarter and there was a chaos and unexpected eventuality was in view in the area on 03/05/2023 after the Tribal solidarity peace rally organised by "ATSUM" produced an effect of eventual bloodshed, damaged the movable and the immovable properties in between the Kukis & Meiteis communities being suddenly into view initially at Churachandpur District, Manipur and spreading abroad valley and hilly District of Manipur inhabited by Meiteis & Kukis communities. But they can't say whether the unwanted looting/theft of the properties belongs to the complainant was committed by any unruly mob members, any habitual offender/ criminals or any miscreants of the residents of Imphal, Manipur.

That, during verification and establishment of the ownership of the aforesaid involved vehicle mentioned in the complainant report i.e vehicle bearing Regd. No. MN01F-4161 during which the ownership of the vehicle was found registered in the

name of Shri Loitongbam Romen Singh a resident of Wangoo Laipham Makha Leikai, Thoubal District, Manipur and having model: Honda Motorcycle & Scooter India (P) Ltd and Engine No.ME4JF504FFT413048. But due to the recent ethnic violence erupted in the state of Manipur upon one another's communities; it has not been possible to visit Wangoo Laipham Makha Leikai, Thoubal District, Manipur.

So, there is an evident of committing a cognizable offence, looting/theft of the properties belongs to the complainant.

Hence a case under FIR No. 971(7)2023 LPS U/S 446/448/420/34 IPC has been registered upon the unknown culprit for investigation. Investigation is in progress.

It is therefore submitted for favour of your kind information and further necessary action please.
