
Sir,

I have the honour to state that, on 04-05-2023 at around 2:00 pm some unknown miscreant suspected to be a members of Meitei Youth Organisations, Meetei Leepun, Kangleipak Kant Lup (KKL), Arambai Tenggol and World Meitei Council (WMC), Schedule Tribe Demar Committee (STDC) numbering about 1000-2000 persons carrying sophisticated weapon like A. Rifles, SLR, INSAS and .303 Rifles, forcefully entered our locality, Khongsai Veng, Laiphai Khunou, Imphal East, 795010, after looting all the moveable properties and cash, they burnt down my house alongwith the household properties including two wheelers Duet hero, Jeweller, Furnitures, Utensils and grains. etc.


The approximate value of lost property is calculated at about Rs. 5 crores


