I have the honour to state that, on the intervening night of 03-05-2023 at around 10:00 some unknown miscreants suspected to be a members of Meitei Youth Organisations, Me Leepun, Kangleipak Kanba Lup (KKL), Arambai Tenggol and World Meitei Council (WN Schedule Tribe Demand Committee (STDC) numbering about 500-600 persons carr sophiscated weapons like AK Rifles, SLR, INSAS and .303 Rilfes, forcefully entered our Localia village No. 91/Meitei Langol, PS- Lamphel, Imphal West, Manipur after looting all the move properties and cash, they burnt down my house with all the household properties inclu-Jewellery, Furnitures, Utensils and grains. etc.

The approximate value of lost property is calculated at about Rs. 80-90 Lakhs.

It is, therefore, requested you to kindly registered a regular case and take necessary legal ac against the culprits according to law.
