

Subject : Report.

Sir,

I have the honour to state that, on the intervening night of 03-05-2023 at around 10:00 some unknown miscreants suspected to be members of Meitei Youth Organisations, Me Leepun, Kangleipak Kanba Lup (KKL), Arambai Tenggol and World Meitei Council (WN Schedule Tribe Demand Committee (STDC) numbering about 500-600 persons carrying sophisticated weapons like AK Rifles, SLR, INSAS and .303 Rifles, forcefully entered our Local village No. 91/Meitei Langol, PS- Lamphel, Imphal West, Manipur after looting all the move properties and cash, they burnt down my house with all the household properties including Jewellery, Furnitures, Utensils and grains. etc.

The approximate value of lost property is calculated at about Rs. 80-90 Lakhs.

It is, therefore, requested you to kindly registered a regular case and take necessary legal action against the culprits according to law.
