



Sir,

I have the honour to state that, on 04-05-2023 at around 3:15 pm some unknown miscreants suspected to be members of Meitei Youth Organisations, Meitei Leepun, Kangleipak Ka Lup (KKL), Arambai Tenggol and World Meitei Council (WMC), Schedule Tribe Dem Committee (STDC) numbering about 1000-2000 persons carrying sophisticated weapon like Rifles, SLR, INSAS and .303 Rifles, forcefully entered our locality, Khongsai Veng, Laiph Khunou, Imphal East, 795010, after looting all the moveable properties and cash, they burnt down my rented house alongwith the household properties including Hero Pleasure scooter bearing Re No. MN01 AM0900, NV Scooter, Jewellery, Furnitures, Utensils, Clothes and grains. etc.

The approximate value of lost property is calculated at about Rs. 6 Lakhs

It is, therefore, requested you to kindly registered a regular case and take necessary legal action against the culprits according to law.
