Sir,

I have the honour to state that, on 04-05-2023 at around 09:00 pm some unknown miscreants suspected to be a members of Meitei Youth Organisations, Meitei Leepun, Kangleipak Kanba Lup (KKL), Arambai Tenggol and World Meitei Council (WMC), Schedule Tribe Demand Committee (STDC) numbering about 600-700 persons carrying sophisticated weapon like AK Rifles, SLR, INSAS and .303 Rifles, forcefully entered our locality, Phaipijang (Spring villa) Langol. Lamphelpat, Imphal West about 46 Km from Saikul-PS, after looting all the moveable properties and Cash, they burnt down my house alongwith the household properties including one Swift car bearing Regd. No.MN01AS4731, Royal Enfield Regd. No. MN04G 4321, Jewellery, Furnitures, Utensils Clothes and grains. etc.

The approximate value of lost property is calculated at about Rs. 1.5 crore

It is, therefore, requested you to kindly registered a regular case and take necessary legal action against the culprits according to law.
