Sir,

I have the honour to state that, on 04-05-2023 at around 06:30 pm some unknown miscreants suspected to be a members of Meitei Youth Organisations, Meetei Leepun, Kangleipak Kanba Lup (KKL), Arambai Tenggol and World Meitei Council (WMC), Schedule Tribe Demand Committee (STDC) numbering about 600-700 persons carrying sophisticated weapon like AK Rifles, SLR, INSAS and .303 Rifies, forcefully entered at National Game village, Inside NorthEast Office, about 46 Km South from Saikul-PS, after looting all the moveable properties and Cash, they burnt down my office alongwith the office properties including 2 two wheelers a) Activa bearing Regd. No. MN02G 0233 & one Electric Bike, Tables, Chairs Furnitures, Electronic gadgets, Kitchen items and Bed room items etc.

The approximate value of lost property is calculated at about Rs. 20-30 Lakhs

It is, therefore, requested you to kindly registered a regular case and take necessary legal action against the culprits according to law.
