Sir,

I have the honour to state that, on 04-05-2023 at around 09:30 pm some unknown miscreants suspected to be a members of Meitei Youth Organisations, Meitei Leepun, Kangleipak Kanba Lup (KKL), Arambai Tenggol and World Meitei Council (WMC), Schedule Tribe Demand Committee (STDC) numbering about 600-700 persons carrying sophisticated weapon like AK Rifles, SLR, INSAS and .303 Rifles, forcefully entered our locality at National Game village, Quarter No. B-149, Zone-4 about 46 Km South from Saikul-PS and looted all the moveable properties and Cash including Furnitures, Utensil, Clothes and Grains etc.

The approximate value of lost property is calculated at about Rs. 10-15 Lakhs

It is, therefore, requested you to kindly registered a regular case and take necessary legal act against the culprits according to law.
