Sir,

I have the honour to state that, on 04-05-2023 at around 11:30 am some unknown miscreant suspected to be a members of Meitei Youth Organisations, Meetei Leepun, Kangleipak Kanb Lup (KKL), Arambai Tenggol and World Meitei Council (WMC), Schedule Tribe Deman Committee (STDC) numbering about 600-700 persons carrying sophisticated weapon like AR Rifles, SLR, INSAS and .303 Rifles, forcefully entered our locality, National Game village Lamphelpat, Imphal West, Manipur about 46 Km South. They looted all the moveable properties and cash, including one Activa, Jewellery, Furnitures, Electronics items, Utensils, Clothes and grains. etc

The approximate value of lost property is calculated at about Rs. 25 to 30 Lakhs.

It is, therefore, requested you to kindly registered a regular case and take necessary legal action against the culprits according to law.
