

Subject : Report.

Sir,

I have the honour to state that, on 04-05-2023 at around 3:10 pm some unknown miscreants suspected to be members of Meitei Youth Organisations, Meetei Leepun, Kangleipak Kanba Lup (KKL), Arambai Tenggol and World Meitei Council (WMC), Schedule Tribe Demand Committee (STDC) numbering about 1000-2000 persons carrying sophisticated weapon like AK Rifles, SLR, INSAS and .303 Rifles, forcefully entered our locality, Khongsai Veng, Laipham Khunou, Imphal East, 795010, after looting all the moveable properties and cash, they burnt down my house along with the household properties including 2 four wheeler (Kia Seltos, Swift bearing Regd. No. MN01 W 9887) Activa, Jewellery, Furnitures, Electronic Gadgets, Utensils, Clothes and Grains. etc. Moreover, my brother namely, Mr. Lunminlal Haokip (27) yrs got bullet injury on his person. The approximate value of lost property is calculated at about Rs. 2 to 3 crores.

It is, therefore, requested you to kindly registered a regular case and take necessary legal action against the culprits according to law.
