

Subject: - Report of obstruction to public servant while performing duty,  
attempt to murder, wrongful restraint, damage to Govt. property,  
snatching of arms and ammunition etc.

Sir,

I am to report that on 17/7/2023 at about 9:35 pm on returning back from Malom to Imphal (PHQ) on duty, I Hav. No. 1211878, Panmei Gaikhangam Kabui along with other escort, Hav. Ng. Phazii, Rfn. Th. Basanta Singh, Rfn. Gajendra Kumar, Rfn. K. Rabichandra Sharma, Rfn. Salam Sanjit Singh, Rfn. Salam Hemanta Singh, Rfn. W. Romio Meitei, Rfn. A. Nanao Singh, C/Driver S. Joy Singh and Shri Kabib K, IPS, IGP(Z-II)/(Int.) were forcefully stopped by unruly mob of 200 (two hundred) people at Kwakeithel Bazar near Delta care, Imphal West. The unruly mob were carrying deadly weapons like wooden sticks, Iron rod etc. We came out of the vehicle and explain to the mob that we are policemen in uniform and we are on duty and also warned them for violating curfew imposed by District Magistrate-IW. But the mob picked up argument and started forcefully taking out items from the main vehicle Maruti Suzuki Ciaz (white in colour) bearing registration No. MN01AS-0071 and started damaging the windshield etc. We tried to stop the mob from damaging the government vehicle but the mob started pushing us and snatched our arms, we tried to pull back our weapons from their hand, in the meanwhile more mobs joined and started attacking our vehicles and our body. To save our lives we gave body support and protection to each other and moved away from car and escaped, in the entire process the following were injured: -

- a) Rfn. No. 132001270 A. Nanao Singh got knee injury.
- b) C/Driver No. 10D1193 S. Joy Singh got eye injury.

And the following items were snatched /lost: -

- i) 1(one) AK magazine with 30 (thirty) rounds snatched from C/Driver S. Joy Singh.
- ii) 1(one) 9 mm Pistol with 2(two) magazines and 20 rounds.
- iii) 2(two) antiriot Tear gas gun with 30 shell.
- iv) Cash amount of Rs. 49,500/- (of IGP-Z/II)
- v) 4(four) BP jackets.
- vi) 5(five) Helmet (Pucca)

The Govt. Vehicles:

- i) No. MN01AS-0071 Maruti Suzuki Ciaz was set fire and fully damaged.
- ii) Maruti Gypsy No. MN01AK-8081 and No. MN01S-5520 were fully damaged.

So, I request you to kindly take up necessary action to meet the justice.
