

was attacked, ransacked, destroyed, looted and burned by a Group of Meeitei/Meiteis community, who were instigated by Meitei Leepun and Arambai Tenggol of Valley based CSO's.

These criminals broke open my gate(s), ransacked destroyed and looted every valuable property from my "Owned/Rental" house, and premises worth Rupees 4580,000
(Approx) and they burnt down all the remaining things.

Therefore, with utmost respect, I request you to take strong actions against the perpetrators by registering an FIR under relevant sections of the Indian Penal Code.
