

Subject: First Incident Report- Major theft at Axis Bank Ltd. Churachandpur Branch.

Dear Sir/ Madam,

We, Axis Bank Ltd. Formally known as UTI Bank Ltd. (herein after referred to as 'The Bank') having its registered Office at Trishul-3rd Floor Opp. Samastheswas Temple, Near Law Garden, Ellisbridge, Ahmedabad-380006, and its corporate Office at Bombay Dyeing, Pandurang Budhkar Marg, Worli Mumbai-400025, and among other places are of its Branch Office situated at Axis Bank Ltd. Teddim Road, Churachandpur, Manipur- 795128 would like to state as follows:

- 1). That, The Bank was closed on 3rd May, 2023 at around 4:00 pm. After that, today the 10 th July, 2023, while opening the Branch it has been found that the Churachandpur Branch has been vandalised by unidentified miscreants which came to notice today morning when Branch was opened.
- 2). Branch staffs have observed that miscreants have broken the Bathroom ventilation situated on the South East corner of the Branch to entered the Bank and they have damaged the Vault room concrete wall by making a hole.
- 3). Branch Officials, immediately brought the incident to the noticed of Senior Management at Circle Office that the vault room was damaged and some miscreants have entered and broke open the Lockers inside the vault and have stolen the cash of Rs. 1,29 Cr, and all gold ornaments from the vault. Valuations of such gold ornaments will be done after we get the exact report from the goal loan processing Department based on Collateral values at current date. Also CCTV system has been taken away by the miscreants value at Rs. 11,8351 /-

Therefore, considering the safety and security of the Branch premises, Branch staffs (including female staffs) customers and Bank assets due to such any unexpected event of robbery which came to noticed today. We request to kindly accept this FIR and investigate the matter and provide police protection to Branch in Churachandpur Branch at the earliest.
