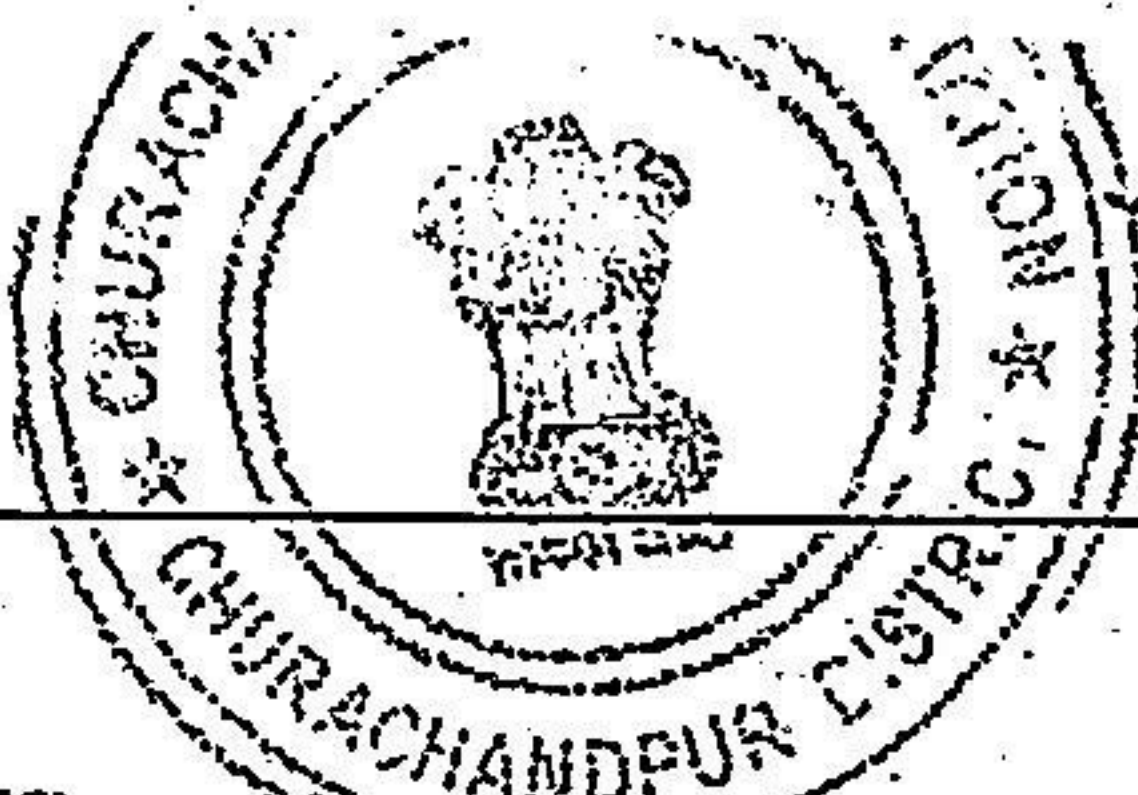

FIRST INFORMATION REPORT

Sir,

1. Please refer to the statement published on Imphal Free Press newspaper dated 25 Jun 2023 by Mr Sunil Karam, former president of United Committee Manipur (UCM) alleging the biased attitude and action of Assam Rifles and claiming that AR troops are hand in gloves with Kuki Militants operating in the state. The statement purports to give out unverified and false information aimed at maligning the Assam Rifles and the Govt. The imputation/assertions in the statement clearly aimed at spreading disaffection, are prejudicial to national integration and prime facie violative of Sec 153 A of the IPC. The statement purposefully promotes enmity between communities which is prejudicial to maintenance of harmony being sought to be achieved in the current situation. The same may also amount to bringing hatred/excite disaffection towards the Assam Rifles, an agency of the Government contrary to the Section 124 A of the IPC.
2. The publication of the article has been done with ulterior motives to defame the Assam Rifles thus violative of Sec 499 and 500 of the IPC.
3. In addition to endangering lives of troops of Assam Rifles and their families residing in the State, in the ongoing communal violence, publishing such manipulated statement is prejudicial to the maintenance of peace and is likely to further spread ill will between communities and also tends to defame and lower the morale of the Assam Rifles, an armed force of the Union in performance of its duty.
3. Giving due regard to the ongoing sensitive law and order situation prevailing in Manipur and adjoining states, it is requested that an investigation in accordance with the law be carried out in respect of Mr Sunil Karam, former president of United Committee Manipur (UCM) responsible for publishing unverified facts of such inflammatory nature capable of causing provocation and disharmony amongst the masses against the Assam Rifles.

'Peace can be restored in Manipur if Centre acts sincerely'

Peace and harmony can be restored in the state if the central government acts sincerely and starts taking action in the right direction, Sunil Karam, former president of United Committee Manipur (UCM), said on Sunday.

Speaking during a one

day sit-in-protest staged at Andro Bazaar on Sunday which was jointly organized by Meira Paibi Apunba Lup, Andro in collaboration with Apunba Manipur Kanba Ima Lup (AM-KIL) and All Andro Shopkeepers and Vegetable Vendors' Association, he said that violence in the state has crossed over 50 days and it is in the hands of the

centre to restore peace and normalcy.

Sunil alleged that the present crisis in the state is between Kuki militants supported by Assam Rifles and Meitei villagers and not between armed Kuki Militants and Meitei villagers.

The crisis can be controlled only when the central government controls

the Kuki militants under suspension of operation, he asserted, adding that the people of Manipur are confused by the silence of PM Modi and have even begun to question if Manipur is a part of India.

Kuki militants are indulging in narco-terrorism by confining to poppy culti-

vation under the nose of Assam Rifles while the central government remains as a mute spectator, he alleged.

Protesters held placards that read, "stop narco-terrorism in Manipur", "no separate administration in Manipur", "withdraw SoO in Manipur", "implement NRC in Manipur", "go back Assam Rifles" and others.

In the current ongoing ethnic crisis in the State, near about 10000 Meiteis, 6000 Kukis, 1000 Nagas, 200 Mizos and 16 Nepalis have been rescued by Assam rifles troops. They have been provided food, accommodation and a secure environment till they were transported to safe zone. Approximately 23000 people were transported to safe zones and Approximately 13000 people were moved from valley to hills while 10000 people were moved from hills to valley by the AR.

The data above shows functioning of AR in a nonpartisan manner all throughout the crisis.

Upholding their commitment to impartiality and protecting of human resources of Manipur, the AR ensures fair treatment, security and harmony for all communities by fostering harmonious relationship and providing security to the region, They have had an unblemished track record of promoting unity and inclusivity amongst the diverse tribals groups fostering a sense of trust and mutual respect.

It is appealed that one-sided views and partisan comments given by one particular community, projected through the esteemed media, may be avoided as this may lead to firming up of a falsified narrative which is regrettable.
