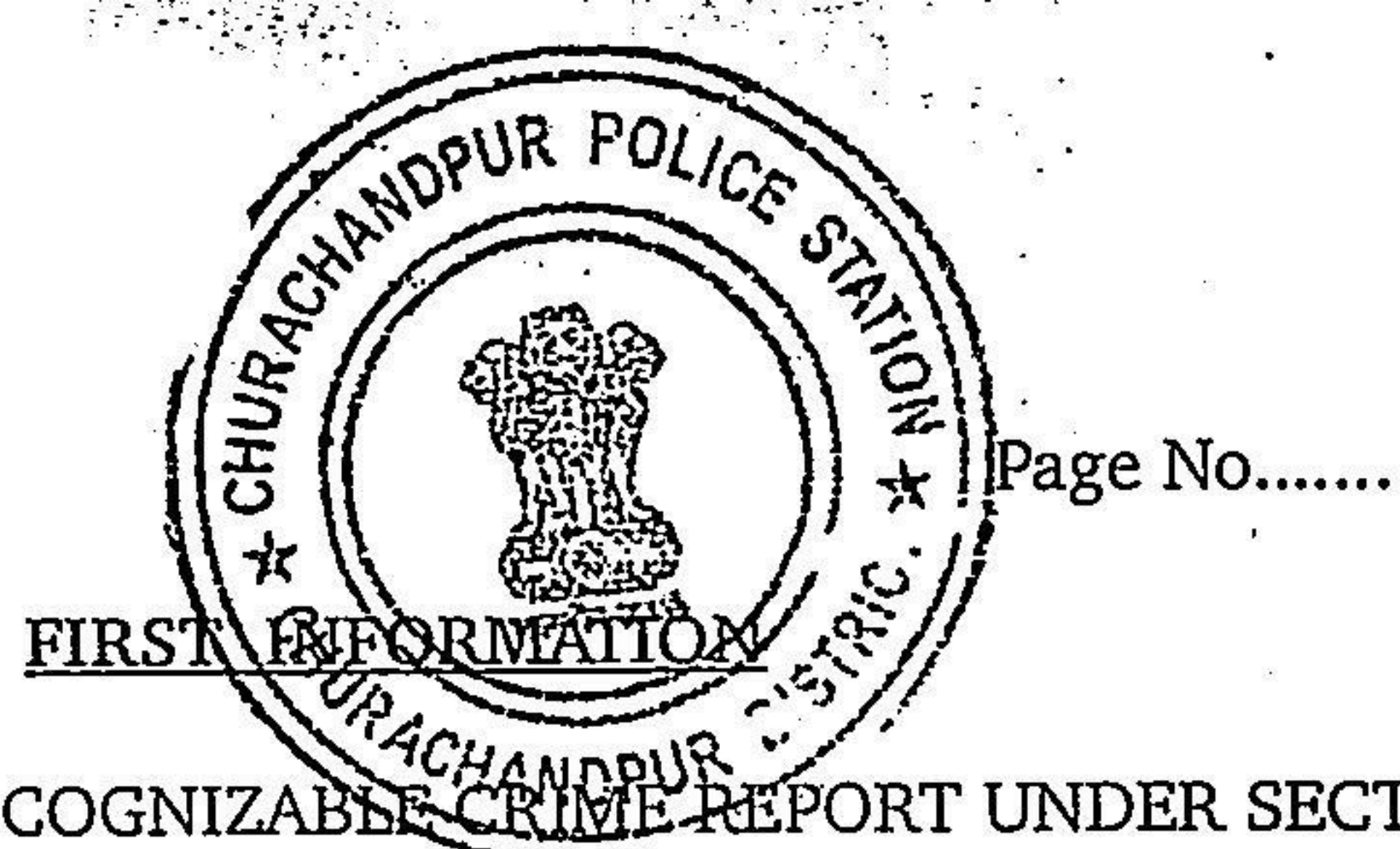



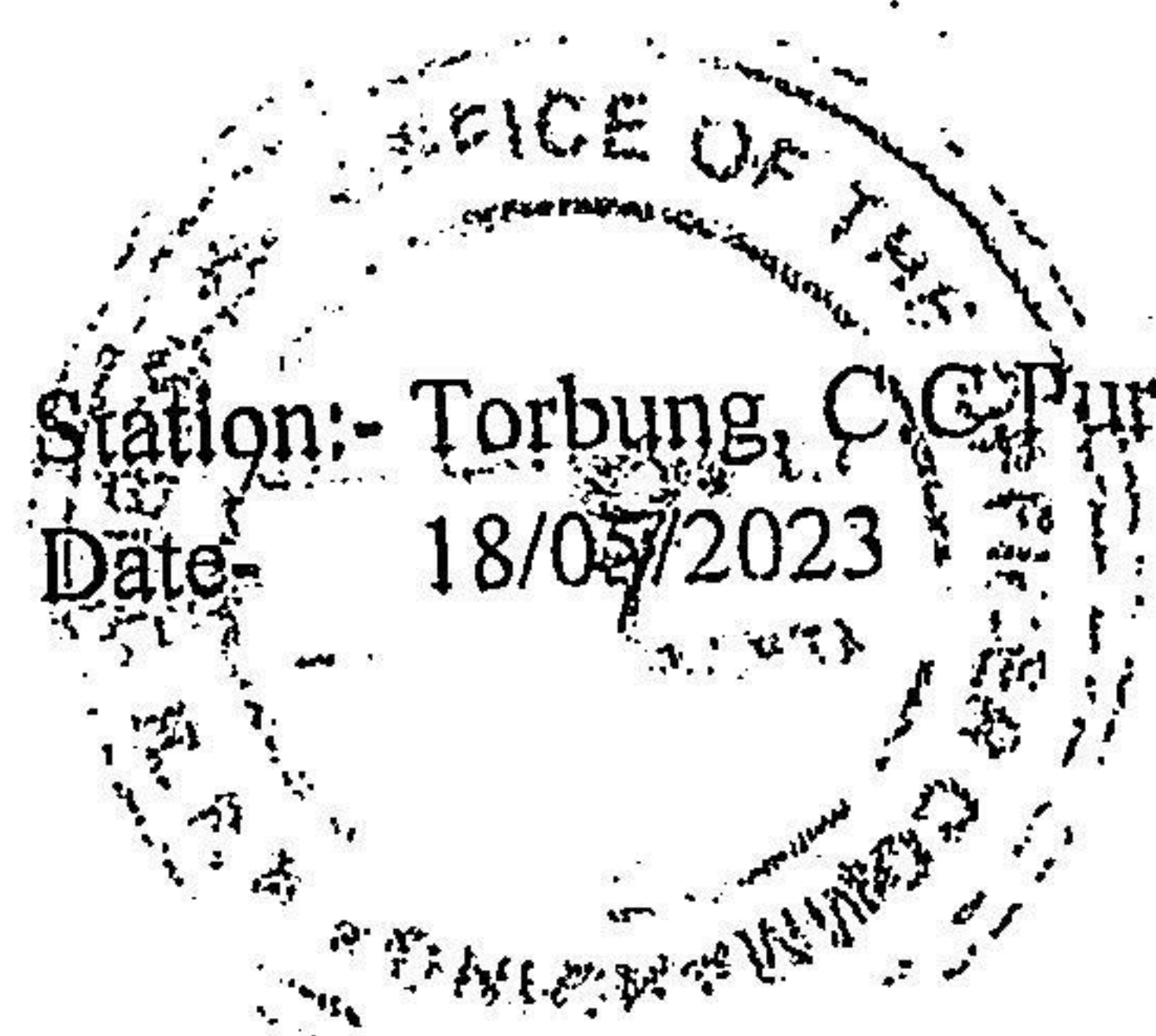
REG. INCIDENT REPORT.

It is certified that D/133 is deployed for Law and order duty in the Torbung village under P.S: Churachandpur, Distt- Churachandpur (Manipur). In the intervening night of 17-18 ^{TUN} May/2023, at around 2320 Hrs to 0300 Hrs in the general area of Torbung Bazar under P.S- C.C.Pur, Distt: C.C.Pur arson was seen and heavy firing was being heard. Since sound of fire was coming from the Distt- Bishnupur axis village side form a distant area (Towards east of Torbung Bazar) our troops were in stand-to mode and were dominating the area (.) In the mean time some armed miscreants/ underground elements came close to the piquet of C.R.P.F at Torbung Bazar and started firing on our side (.) In response our troops after carefully assessing the situation took safer position (.) The armed miscreants fled away towards the jungle area of the eastern side of Tornung Bazar and taking advantage of darkness and vegetation. During the fire of miscreants Force No. 971282292 HC/GD Jayashankar Prasad Singh of 134 Bn attached with Adhoc-JKD while taking safe position got injured on his left leg under knee (.) After Frist-Aid Force No. 971282292 HC/GD Jayashankar Prasad Singh was sent to 09 Assam Rifle Kangvai for further treatment.
