Today i.e 19/07/2023 at 2:00 PM received a reliable information that on the same day at around 1:30 PM some unknown persons are transporting fertilizers suspected to be stolen from some other places at Torbung Bazar. Along with Police Party rushed to the area and found 07 (Seven) persons transporting manually on foot. They were detained and on verification they identified themselves as: 1) Thongminlal Baite (29) s/o Jangkholun Baite of Lungdeiphai village, CCPur, 2) Thangjangam Kipgen (26) s/o (L) Ngulkhokam Kipgen of K. Songdojang village, CCPur, 3) Mangkhohen Kipgen (22) s/o satkam Kipgen of K. Songdojang Village, CCPur 4) Ngamboilen Haokip (19) s/o Haongam Haokip of Leinom village, CCPur 5) Lunminthang Haokip (18) s/o Lunkhohen Haokip of Leinom Village, CCPur 6) Satkhoh Kipgen (22) s/o Janglam Kipgen of K. Songdojang village, CCPur 7) Manggoulen Kipgen (19) s/o Nehthang Kipgen of K. Songdojang Village, CCPur. They admitted that they had taken the fertilizers from houses abandoned by the house owners from different places. Altogether 36 (thirty Six) Bags of fertilizers was found on the western side of the road. The 07 (Seven) persons were arrested / Apprehended at 02:45 PM and the 36 (Thirty Six) bags of fertilizers were seized at 03:00 PM.

Hence a Suo-Moto case under FIR NO. 1208(07)2023 CCP-PS u/s 379/34 IPC has been registered for Investigation.
