Today i.e 19/07/2023 at 5:40 PM: unknown miscreants numbering about 70-100 including womenfolks have forcefully entered and assembled at the premises of Churachandpur Police Station on hearing that some youths were arrested from Torbung Bazar at a six with an intention to cause harm to the police personnel and rescued the arrested persons. They were stopped at the main gate and at the gates leading to the office but the police personnel were outnumbered, as a preventive measures and inorder to disperse the gathered mob several rounds of tear gas shells and ammunitions were fired in the air. Instead of withdrawing the gathered mob charged inside the office of the Police Station, checking every room and destroying and vandalizing the CCTV fitted at the police station, forcefully rescued the 7 (seven) arrested accused persons who were under custody namely, 1). Thongminlal Baite(29) s/o Jangkholun Baite of Lungdeiphai Village, CCPur, 2) Thangjangam Kipgen (26) s/o (L) Ngulkhokam Kipgen of K. Songdojang Village, CCpur 3) Mangkhohen Kipgen (22) s/o Satkam Kipgen of K. Songdojang Village, CCpur 4) Ngamboilen Haokip (19) s/o Haongam Haokip of Leinom Village, CCPur 5) Lunminthang Haokip (18) s/o Lunkhohen Haokip of Leinom Village, CCPur 6) Satkhou Kipgen (22) s/o Janglam Kipgen of K. Songdojang Village, CCpur 7) Manggoulen Kipgen (19) s/o Nehthang Kipgen of K. Songdojang Village, CCPur On their way out they have stolen away the seized items ie 36 (thirty Six) Bags of fertilizers which were kept at CCP-PS campus.

Hence a Suo-Moto case under FIR No. 1210(07)2023 CCP-PS u/s 143/148/224/427/447/379/34 IPC has been registered for Investigation.
