As application submitted to The Deputy Commissioner, Churachandpur by Lalnunthar (Assistant Director) District Sericulture Office: Churachandpur to The Deputy Commissioner, Churachandpur regarding the farm of Sericulture Department Government of Manipur located at Bualjang that has been destroyed by unknown persons and all the plantation as well as buildings and equipment has been destroyed on 25th July 2023 which was forwarded to OC/CCP-PS by SP/CCP(C-9/1(C/Riot, ST & M)/SP-CCP/2023/3559 dtd:26/07/2023 was received on 26/07/2023 and the same was endorsed to me for enquiry. As endorsed on 26/07/2023 at 1:30 p.m. I along with police team from CCP-PS went to Buoljang Sericulture farm for enquiry and found that it has been vandalized and destroyed by unknown persons on 25/07/2023, and most of the plantation has been cut down and destroyed, most of the structures located inside the campus has been destroyed but some of the buildings still remain intact.

In this regard, a regular case needs to be registered for smooth investigation.

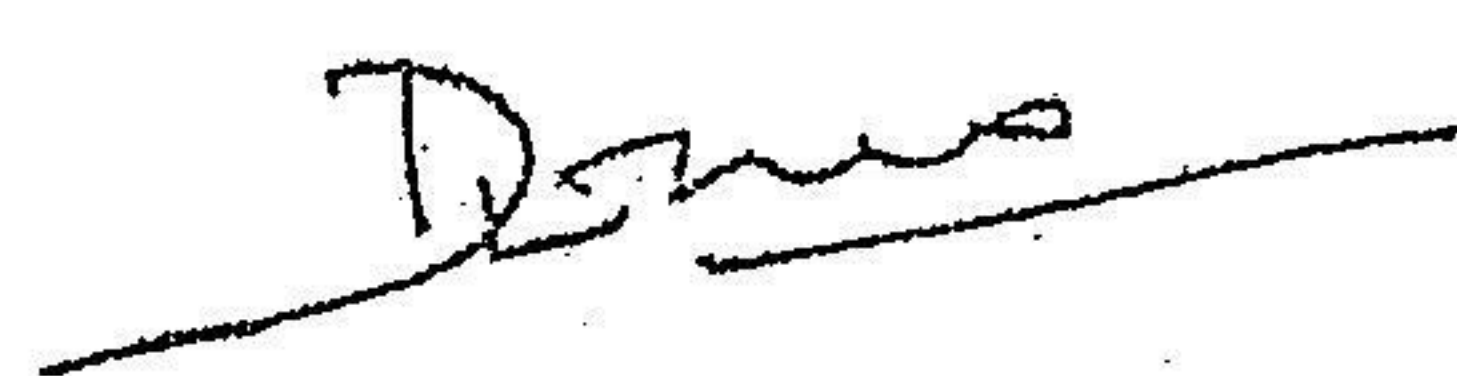
