



Subject: - Report against the killing of Mr. Lunminthang Lupheng (39 years), S/o (L) Lengjang Lupheng., a resident of L. Bolkot Village, P.O., P.S. & District-Churachandpur, Manipur.

Respected Sir,

With great grief and concern, I have the honour to make this first information report (FIR) to you regarding the unfortunate incident of shooting and killing of the above named victim, which I do as under:

1. That, I am the *Bepa* (Household council member) of the above named victim Mr. Lunminthang Lupheng. We belong to the Any Other Kuki Tribe, a Scheduled Tribe under the Constitution of India, and the victim is a permanent resident of the address mentioned above.
2. That, on the 27th of July, 2023 at about 1:30 PM, the above named victim was on volunteer duty at around P. Geijang Village area. And, at the time of carrying on volunteer duty of guarding the area from the attack of the majority community Meiteis, he was unfortunately shot at on his left lower neck by a bullet which exited on the right shoulder blade. He unfortunately succumbed to the bullet injuries.
3. That, the dead body of the above named victim was taken and kept at the Churachandpur District Hospital Morgue at about 3:30 PM of the 27th July, 2023.
