Sir,

With due respect, I would like to state that as per SP, CCPur order No. B-12/13(L&O)/SP-CCP/2018/2418 dated 01/06/2023 and CO, 1<sup>st</sup> IRB, authorisation for Movement dated 10/08/2023, I, the undersigned alongwith my team was detailed to replace the existing duty personnel at M. Bongmol Village and its adjoining areas. We took post on 10/08/2023.

On the night of 20/08/2023 at around 09:42 PM, our duty post was alerted by a short round of firing, supposedly, from assault rifles fired from the across eastern side of Imphal River along Southern Tanjeng Khunou/Northwest hill-lock of M. Mollum around 300 meters from 1<sup>st</sup> IRB M. Bongmol Post. Our team was made ready and keeping strict vigil, however, since the firing discontinued, duty personnel was made to stand-down at around 11:20 PM except for the sentries on duty. Later, at around 11:45 PM, shots of fire came from the same location, but at more intense rate and we were informed that a large number of armed miscreants, suspected to be valley based UGs of KYKL, UNLF & PLA outfits, shots fire towards M. Bongmol Village and its adjoining area and started advancing towards the village. The 1<sup>st</sup> IRB personnel intervened to stop the advancing and avert the situation. Though the attacker fired intensely, the duty personnel retaliated methodically and returned fire intermittently enough to avert the situation. The situation subsided at around 04:00 AM the next morning i.e. on 21/08/2023. Details of ammunition expended are given below:
