Subject: - Report against the killing of-

- (i) Mr. Jangkhomang Haokip, aged about 42 years, S/o Mangjalet Haokip, a resident of G. Mongjang Village, P.O., P.S. & District- Churachandpur, Manipur; and
- (ii) Mr. Johny Lalkholien Guite, aged about 30 years, S/o (L) Khupthang Guite, a resident of Khamenlok Village, P.O. & P.S. Saikul, Kangpokpi District, Manipur.

Respected Sir,

With great grief and concern, I have the honour to make this first information report (FIR) to you regarding the unfortunate incident of shooting and killing of the above named victims, which I do as under:

1. That, I am the son of the above named victim No.(i) *Jangkhomang Haokip*. We belong to the Any Kuki Tribe, a Scheduled Tribe under the Constitution of India, and we are residents of the address mentioned above.
2. That, on the 5th of August, 2023 at about 6:30 AM, my above named father and victim was called for village duty as volunteers at Phuoljang Village. And, at the time of carrying on volunteer duty of guarding the village from the attack of the majority community Meiteis, my father and the victim No.(ii) mentioned above, *Johny Lalkholien Guite*, were fatally wounded from gun shots. They both unfortunately succumbed to the bullet injuries.
3. That, the dead bodies of my father and the other victim were taken and kept at the Churachandpur District Hospital Morgue at about 11:00 AM of the 5th August, 2023.

4. That, it may also be reported here that the attackers were believed to be members of the Arambai Tengol, Meitei Leepun and the valley based UGs who were led by the Manipur State forces like- the Indian Reserve Battalion (IRB), Manipur Police Commando and the Manipur Rifles.

I, therefore, request you to kindly register my report and investigate the matter, arrest the culprits involved in the gruesome act and book them under relevant sections of the law of our country. And, for this act of kindness, I shall always remain thankful to you and obliged.
