Sir,

As per endorsement, I have made an enquiry in c/w the report made by JC-3600382 Nb/Sub. Harish Singh, HQ 27 Sector (36 AR) that on 3rd August, 2023 a group of volunteers at the instigation of Mr. Lianmuanthang Valte, President YPA Gen HQ and Co-Convenor of JPO had forcibly taken out the mortal remains of the victims of ethnic clash from temporary District Hospital Morgue, CCPur situated at Churachandpur Medical Collage and attempted to proceed towards peace ground which had disturbed the law and order situation and caused a big threat to the lives and properties of villages from Kangvai to Torbung Bangla.

On enquiry, it is found that, on the day of the incident i.e 3rd Aug, 2023 at around 11:00 AM, about 100/200 Churachandpur volunteers comprising different communities assembled at Churachandpur Medical Collage and brought out the mortal remains from the Morgue and loaded onto some trucks with an intention to proceed towards Peace ground, Tuibuong. Timely intervention by Assam Rifles and other security personnel deployed at the place prevented the mortal remains from being transported.

From the accounts of the security personnel present at the time and other eye witnesses, it has been established that some of the vehicles have the markings/indications of YPA implying that the YPA Gen HQ President had authorised and instigated the action of the volunteers.

Shri T. Ranjit Singh, Commissioner (Home), Govt of Manipur had already circulated a Standard Operating Procedure (SOP) vide No. H-3608/2/2023-HD-HD dated the 2nd August, 2023 for identification and disposal of the dead bodies in c/w the present law and order situation in the state. The dead bodies are to be disposed off only after being verified and authenticated by the concerned SP and DC.

Further enquiry reveals that a large number of Meitei people numbering up to 1,00,000 from Bishnupur side reached Kangvai with an intent to proceed to Sericulture Farm, Bualjang with an intent to stop the burial in the government farm land which lead to tense situation and imminent threat to lot of lives and properties as a result of the dead bodies being taken out from District Hospital Morgue, CCPur. However, they were prevented further from proceeding towards Sericulture Farm, Bualjang by the strong teams of security personnel including RAF deployed at Kangvai junction.

The acts done by Mr. Lianmuanthang Valte, President YPA Gen HQ and other volunteers contravenes section 188 IPC i.e. disobedience to order duly promulgated by public servant and section 153 IPC i.e. wantonly giving provocation with intent to cause riot. As such, registration of a case is highly required for further investigation.

In this regard, I am submitting my enquiry report for your kind perusal and taking further necessary action.
