With due respect, I would like to report that on the 5<sup>th</sup> of August, 2023 around since 3 AM some miscreants who were disguised as police personnel of Bishnupur Police and Commando attacked my village namely Pholjang, P.O., P.S & District- Churachandpur, Manipur.

During such attacked heavy firing of automated weapons and artillery shells were used by those personnel who eventually endangered the lives of my villagers. It further ensued an exchange of fire between Village guards with the perpetrators, which lasted till the evening of the same day.

Such acts of Miscreant disguised as State Police personnel with high handedness have caused severe psychological effects on the mind and hearts of my villagers. Similarly, houses of the resident (comprises of 30 houses) were fired upon indiscriminately, makes a porous hole out of the fired bullets. Therefore, we are at the state of vulnerability from the acts of the said miscreants. Insecurity has prevailed into the minds of the villagers.

I, therefore, seek your kind office to intervene and look up into the matter and register a regular FIR against such heinous acts perpetrated by the persons in State police uniform.
