With due respect, I would like to report that on the 4th and 5th of August, 2023 some miscreants who were disguised as police personnel of Bishnupur Police and Commando attacked my village namely Songdo, B.P.O- Kangvai & PS- Churachandpur, District-Churachandpur, Manipur. Comprises of 41 household.

During such attacked heavy firing of automated weapons and artillery shells were used by those police personnel firing from the Masjid of Kwakta Ward No. 8, eventually 6 villagers/ village guard have suffered casualty, some were inflicted with major injury and later rushed into District Hospital of Churachandpur. Such incessant acts of firing upon the villagers perpetrated by the disguised police personnel render us to a state of insecurity and endangered our lives.

Due to such high handedness meted out by the miscreants who were disguised as State police personnel makes us unable to plough our paddy field. Similarly our church was doused with the mortar shells and 20 houses were filled with holes of bullets.

Therefore, we are at the state of vulnerability from the acts of the State Police. Insecurity has prevailed into the minds of our villagers.

I, therefore, seek your kind office to intervene and look up into the matter and register a regular FIR against such heinous acts perpetrated by the persons in State police uniform.
