

Sub: **Report of criminal intimidation and un-lawful displacement.**

Sir/Madam,

I, the undersigned Shri **Mangpilen Haokip** aged about 27 Years, S/o Shri Lunkhagin **Haokip**, a resident of M.Phainom Village, P.O. Churachandpur, P.S. Sangaikot, Churachandpur District, Manipur, would like to place the following few facts for your kind and sympathetic considerations:-

1. That, I am a schedule tribe belonging to "Any Kuki Tribe" which is one of the recognised tribes within the state of Manipur, India.
2. That, me and my family members are forced to flee from our village on the 3.05.2023 at around 4:30PM when our surrounding Zo Ethnic Tribal Village (Kuki/Zomi/Hmar) namely Lhangching Village which is about 3(three) Kms distance away from our village is torched and burn down by a group of Meitei miscreants suspected to be Arambai Tengol and Meitei Leepun. The Meitei miscreant were abetted by the surrounding Meitei villages namely Napet Village, Tangjing Village, Sugnu Village and others in attacking and torching down the village.
3. That, on being feared for our life, we have deserted our village leaving behind all our assets (Movable and immovable) and home, a total estimated at an amount of around Rs. 15.0000/- (Fifteen Lakhs) approximately. The prevailing status of our village and our homestead land is not known to us anymore.
4. That, we are rendered homeless now due to the ethnic conflict prevailing between the 2(two) communities and we are presently taking shelter at Lajangphai Village, P.O. & P.S. Churachandpur, Dist. Churachandpur, Manipur.

In the light of the above facts and circumstances, i humbly request your good office with folded hands to kindly take strong actions by registering an FIR, initiate an investigation and book the culprit/perpetrator(s) according to the law of the land.
