The Officer-in-Charge, Sangaikot Police Station, Manipur.

Subject: Complaint/Report on the crimes of looting, vandalism, arson attack and discrimination of Scheduled Tribes.

Sir.

With reference to the above subject, I have the honour to report to you as follows:

- That, I am a Scheduled Tribe belonging to the Any Kuki Tribe, which is recognised Tribe under the Constitution of India. And , I am a permanent resident of Khodang Village, P.O. & P.S. Sangaikot, District – Churachandpur, Manipur.
- That, on the 28<sup>th</sup> of May, 2023 at around 7:30 am, a huge contingent of armed radical Meiteis/Meeties suspected to be members of the Arambai Tenggol and Meitei Leepun along with State Police Commando and the Indian Reserve Battalion (IRB) attacked our Village and in the process, they have looted, vandalized and torched my house.
- 3. That, it may be reported here that the Miscreants were shouting slogans like "KANGLEIPAK YAIPHARE", "KUKI HATLO", "KUKI HATLO" etc, while they were carrying out their criminal activities. It seems to me that all these has taken place at the instance of the Manipur State Government as the the perpetrators openly claimed and shouted that nobody would stop them, even the Police because everyone, including top Officials of the Manipur Government are patronizing them and that no harm could done to them.

- 4. That, at the time of the attack we somehow managed to escape to save our lives under the compelling circumstances and thus could not take our belongings to safety and were all burnt. A list of our Properties looted/destroyed/burnt is attached here under with its estimated costs. The total loss suffered is estimated to be about Rs. 6,350,000/- (Rupees Sixty Three Lakhs Fifty thousand) only.
- That, I am filing this report lately because we were at different places for safety and now since we have started to settle at a rented house at Koite Village, P.O. & P.S. Churachandpur, District Manipur. I am filing the same today with a prayer to accept it though filed lately.

In the given circumstances, I humbly pray you to kindly register an FIR to investigate the matter and punish the Perpetrators as per the prevailing provisions of the Law of our Country. And for which act of kindness, I shall always remain thankful to you and obliged.
