I, the undersigned would like to bring forth to your knowledge and report that I, am a permanent resident and native of *Khengmol* Village, P.O.&P.S. *Sangaikot* District *Churachandpur* Manipur and that some armed radicals belonging to the Meetei/Meitei community broke open my rented/residential home and vandalized, looted and gutted/burnt down and all what is within and along with the house was lost to the said meetei/meitei armed radical groups illegal activities a total loss estimated to be at an amount of Rs. *5700000* Only.

Fortunately, me and my family managed to escaped from these criminals who even tried to kill or burn us alive, and now currently taking refuge at, *Thingkangphai Relief Centre*

Therefore I kindly request you to please take action in this matter and come up with positive solution.
