On the same day at 11:20 am, while we were reaching at Singheu Village Under Sangaikot PS, Churachandpur District, Manipur, some unknown persons suspected to be Kuki militants fired upon us and forcefully looted my Diesel Auto bearing registration No.MN02B5134 along with its relevant documents. The approximate value of my Diesel Auto is Rs. 1,50,000/-(Rupees one lakhs fifty thousand).

I could not report to the police station in time due to present unrest law and order situation.

So, I therefore requested to kindly take up necessary legal action against the unknown culprits.
