Sir.

I the undersigned have the honour to report that on 04/05/2023 at @ 11:00 am, I along with my wife have left our work place i.e. Phaisen Village Under Sangaikot PS, Churachandpur District, Manipur by ridding my Diesel Auto bearing registration No.MN03W0573 due to communal riot started from 03/05/2023 between Meitei and Kuki to save our life. On the same day at 11:20 am, while we were reaching at Singheu Village Under Sangaikot PS, Churachandpur District, Manipur. Some unknown persons suspected to be Kuki militants fired upon us and forcefully looted my Diesel Auto bearing registration No.MN03W0573 along with its relevant documents. The approximate value of my Diesel Auto is Rs. 2,00,000/-(Rupees two lakhs).

I could not report to the police station in time due to present unrest law and order situation.

So, I therefore requested to kindly take up necessary legal action against the unknown culprits.
