Subject: Report

Sir,

1. An input was received with respect to move of UG cadres alongwith Arms, Ammunition and other war like Stores crossing Indo-Myanmar border through BP-48 towards gen area of Tuidam Khuangkhai. Two MVCPs , first coln str of 01-01-25 ex COB Sangaikot under Lt Col Sakil Ahmad in gen area Singheu (09 Kms North of COB Tuidam Khuangkhai) and second MVCP with coln str of 01-01-25 ex COB Tuidam Khuangkhai under Maj D P Singh in gen area of Chaljang (03 km west of Tuidam Khuangkhai) were launched at 2215hr.
2. At around 0045 hr, the MVCP at Chaljang noticed move of a white Bolero Pickup. However, the vehicle stopped at a distance of 100m from MVCP and unknown number of individuals were seen rushing out of the vehicle and ran into the thick vegetation down the slope under the cover of the darkness and the vehicle made a quick U-turn and sped away. Immediately, the MVCP coln at Chaljang cordoned the area and after the second coln from Singheu arrived at the location, a thorough search operation was carried out in adjacent jungle area in which two individuals who were hiding in the jungle were apprehended and arms, ammunition and war like stores were recovered from the area.
