Today, i.e., 10/11/2023 at 1:30 pm, received a reliable information that members of Arambai Tenggol led by one of its leaders namely Mr. Korounganba Khuman and suspected members of Valley based Outlawed Organisation namely People's Liberation Army (PLA) Cadres started unprovoked firing from Pombikhok and Chandanpokpi, Bishnupur District towards L. Cananphai, Churachandpur District. The Security Forces deployed at L. Cananphai retaliated the firing and heavy exchanged of fire took place. In the ensuing exchanged of Fire, some members of suspected Arambai Tenggol and People's Liberation Army (PLA) Cadres entered the Foot-Hills of L. Cananphai and started indiscriminate firing towards the Security Forces stationed at L. Cananphai. In the retaliation it is confirmed that one member of suspected PLA Cadres or Arambai Tenggol namely Salam Naoba (35) years s/o S. Premkumar of Moirang Thoya Leikai received bullet injury and was evacuated to Shija Hospital, Imphal for medical treatment.

Hence a Suo-motto case under FIR No. 138(11)2023 SKT-PS, u/s 307/34 IPC, 25 (1-C) A. Act & 16/18/20/39(2) UA(P) Act has been registered for investigation.
