Sir,

I am to bring to your notice that on the 4th May, 2023
Between 12:00 PM – 2:00 PM My residence
located at Siden Village P.O & P.S. Churachandpur.
was attacked by a Group of Meeitei/Meitei's goons numbering 500 to 1,000 men.

These criminals broke open my gate(s) and looted every valuable property from my house and premises worth Rupees 25,00,000/- (approx.) and they burn down all the remaining things.

Fortunately, me and my family managed escaped from these criminals who even tried to kill or burn us alive.

Therefore, with outmost respect I request you to take strong action against the perpetrators by **registering an FIR** under relevant sections of the Indian Penal Codes.
