


Subject: Report on vandalism, looting and burning of properties (Movable & Immovable)

Sir,

I am to bring to your notice that on 24<sup>th</sup> May, 2023 at about 3:45 am, my residence on (Owned) located at Phuaisanphai Village, P.O & P.S. Churachandpur, about 11Kms North from PS, Churachandpur District, Manipur was attacked, looted, destroyed by a group of Meetei/Meiteis.

The criminals broke open my gate(s), destroyed and looted every valuable property from my self owned Three Houses with one separate Toilet, which are all located just adjacent to each other within a single compound. The overall net worth of the properties (Movable/Immovable) worth rupees 1,15,00,000/- (One crore fifteen Lakhs only). The above mentioned premises along with live Cattles and Fishery farm were completely burnt down, looted and ransacked. The premises also have a good number of Agarwood plants which were chopped down and looted by the miscreants.

It may kindly be noted that, due to the traumatic experience and turbulent law and order situation the matter could not be brought to your immediate notice and as such a slight delay in reporting the matter may be observed. It is humbly requested that a slight delay in reporting the matter may not effect the process of bringing the perpetrators to justice.

Therefore, with utmost respect, it is requested to your respectable office that you will take strong action against the perpetrators and took them to justice by registering an FIR under relevent sections of Indian Penal Code (IPC)
