In the light of the above facts and circumstances, it is therefore respectfully requested that your good self may cause the arrest of the miscreants who belongs to the Kuki community involved in the burning/dismantling/damaging my properties and injuring ...... and take up an FIR against them as soon as possible in the interest of justice and urge to the concern authorities to compensate for those who expired and damages all the properties belongs to.
