

Sir,

With due respect I, the undersigned namely Wahengbam Nandakumar Singh (49) S/o (L) W. Amuyaima Singh resident of Zouveng Khuga Tampak Meitei Leikai, Churachandpur, Manipur 795128 beg to submit the following few lines for kind consideration and necessary action.

That on 03<sup>rd</sup> May, 2023 at @ 6:30 pm some unknown persons numbering about 400/500 suspected to be kuki community started attacking my family members and also to my neighbours. Thereafter, they started destroying the house by using JCB which make the houses into broken peices. They even looted my pharmacy Cal drugs, jewelleries ornaments of about 20 mohor. In the said incident my house including properties was destroyed/burnt down badly by using stone/hacking with knife/shot from firearms toward us by the miscreants. A separate sheet showing the particulars of all losses incurred by me is attached along with the present application and estimate value of the damaged and lost items were approximately about 3.5 crore.

In the above facts and circumstances, it is therefore respectfully requested that your good self may cause the arrest of the miscreants who belongs to the kuki community involved in the burning/dismantling/damaging my properties and so, please kindly register an FIR against them as soon as possible for the interest of justice.
